1. Alternates, observers and apologies

SL welcomed attendees to the Modification Panel meeting of the iGT UNC. Apologies for absence were received from Andrew Margan (British Gas), Kirsty Dudley was nominated as the alternate for Andrew Margan. SL thanked the Panel for their co-operation in attending this short notice meeting in order to consider the Final Modification reports for iGT086, iGT096F & iGT098F.

2. Confirmation of Agenda

SL asked the Panel if they had any additional items to add to the agenda for this meeting. The Panel had no additional items.

3. Final Modification Reports

iGT086 - Central Data Service Provider - Implementing iGT UNC changes to support FGO

SL introduced the Modification to the Panel, explaining that this Modification was created in order to be compliant with new government arrangements for FGO. This Modification was initially raised in 2016 and has depended much on the drafting of UNC legal text which resulted in the significant delay of the Workgroup report being completed. The Chair pointed out that this Modification is a Self-Governance status and therefore there will be a 15-day Appeal window after an implementation decision.

The Chair opened up discussions to the Panel on whether there were any comments regarding the Pre-Panel Final Modification Report for iGT086.

IGT UNC

The Panel members believed the aim of the modification was clear and unanimously agreed that this Modification qualified for Self-governance, and that this Modification accurately met the Relevant Objective F.

The Panel was asked to vote on iGT086, the Panel unanimously supported Implementation of this Modification and agreed that this should be included in the 1st June PNID Code release.

Action: EXP1005_01: Code Administrator to notify all parties that iGT086 is to be implemented and prepare for this to be included in the PNID Code Release (1st June).

iGT096F - Correction to the iGT083 legal text now iGT078/79 are complete

SL introduced the Modification, stating that this was raised as a Fast Track modification as alignment was needed in the legal text of iGT083, iGT078 & 079 in time for PNID. SL noted that it was discovered that the legal text for 078 & 079 was based on a legal text which was in the process of being developed in the UNC arena. By the end of the development of the Legal text some assumptions had changed, and therefore, a review was needed and a modification raised.

The Chair opened up discussions to the Panel on whether there were any comments regarding the Pre-Panel Final Modification Report for iGT096F.

The Panel members believed the aim of the modification was clear and unanimously agreed that this Modification qualified for Self-governance, and that this Modification accurately met the Relevant Objective F. AM noted that square brackets had been left within the legal text of the FMR and noted that these should not be contained within the legal text for the iGT UNC. RB confirmed that all square brackets had been taken out of the Modification text when this was implemented in the Code Prerelease.

KD also noted that E.ONs consultation response noted that there was still a gap in the solution and that this was for consideration, and that the solution should be looked at more thoroughly Post – PNID. The Chair invited comments from the iGTs with regards the solution of iGT078 & iGT079. JR noted that ongoing discussions with Xoserve have resulted in them noting this issue on their log, and a joint effort to monitor discrepancies in the SSR files, where a different shipper is named to that referenced in the PSR process, will take place after PNID. JR acknowledged that this may, however, be an issue that will have to be driven by the iGTs.

The Panel was asked to vote on iGT096F, the Panel unanimously supported Implementation of this Modification and agreed that this should be included in the 1st June PNID Code release.

Action: EXP1005_02: Code Administrator to notify all parties that iGT096F is to be implemented and prepare for this to be included in the PNID Code Release (1st June).

iGT098F - Changes to the iGT UNC Code due to changes to the UNC Code

The Chair introduced the Modification noting that this was created to amendment the iGT UNC Code to reflect significant changes to the UNC legal text. The changes take into account additional Project Nexus requirements or updates/amendments to existing requirements. Several UNC modifications have caused change or removed clauses in the UNC Code in preparation for Single service

(UNC432, 434 and 440). As the iGT UNC will be pointing across to the UNC legal text in many cases after the implementation of Project Nexus it is important that these cross-code references are correct.

The Chair opened up discussions to the Panel on whether there were any comments regarding the Pre-Panel Final Modification Report for iGT098F.

The Panel members believed the aim of the modification was clear and unanimously agreed that this Modification qualified for Self-governance and that this Modification accurately met the Relevant Objective F.

The Panel was asked to vote on iGT098F, the Panel unanimously supported Implementation of this Modification and agreed that this should be included in the 1st June PNID Code release.

Action: EXP1005_03: Code Administrator to notify all parties that iGT098F is to be implemented and prepare for this to be included in the PNID Code Release (1st June).

4. Any Other Business

The Chair noted that the Pre-release for the iGT UNC v10.2 has been published on the website, which includes all tree modifications passed for implementation today. As this Code release includes extensive changes to the iGT code, the Chair welcomed any feedback on the clarity of the documents published.

The next Modification Panel meeting will be convened on 17th May 2017.
