### **1. ALTERNATES, APOLOGIES FOR ABSENCE, AND OBSERVERS**

SL welcomed attendees to the ninth iGT UNC Modification Panel meeting of 2015. The Panel noted that Jenny Rawlinson (Brookfield Utilities) was commencing her term on the Panel following reappointment.

Apologies were received from Cher Harris (Indigo Pipelines). Kishan Nundloll was attending as Alternate for Cher Harris in addition to his own role as Pipeline Operator representative.

### **3. MINUTES FROM THE PREVIOUS MEETING**

The minutes from the iGT UNC Panel 15-07 were agreed as a true and accurate record of the meeting.

## 7. UPDATE ON DEVELOPMENT GROUPS

### [iGT056 – UPRN Provision](#)

JR noted that the workgroup for iGT056 had not met since the previous Panel meeting. The Address Data Working Group (ADWG), established by Ofgem, would further discuss the Modification within the wider scope of the industry address data quality issues.

### [iGT071 - Updating the iGT AQ Review Procedures Ancillary Document](#)

KS noted that progression of the Workgroup for iGT071 had been deferred until there was greater certainty around the date of Project Nexus implementation, as this may affect which process is adopted for 2016. The Workgroup would reconsider the position at the Modification Workstream on 1<sup>st</sup> September 2015.

### [iGT075 - Identification of Supply Meter Point pressure tier](#)

KD noted that the Workgroup for iGT075 had not met since the previous Modification Panel meeting. The Proposer would be meeting with industry parties in September 2015 to further discuss the proposed solution; the Modification Workstream in October 2015 was anticipated to review progress to date.

### [iGT078 - Ancillary Document for the New Connections process](#)

KS noted that comments on the latest version of the proposed Ancillary Document had been invited following the previous Modification Workstream. KS would be meeting with KB ahead of the next Workstream to incorporate comments as appropriate, and draft an amended version of the document before 1<sup>st</sup> September 2015. Furthermore, KS would look to circulate an amended Modification Proposal for presentation to the Panel alongside a finalised Workgroup Report.

### [iGT079 - Adding Non-domestic New Connections Framework Ancillary Document](#)

SL noted that Proposer Andrew Margan (British Gas) was looking to develop a revised version of the Ancillary Document and Modification, building on iGT078, and would circulate ahead of the Modification Workstream on 1<sup>st</sup> September 2015.

### [iGT080 - Mandating iGT use of Xoserve Portfolio Data for Shipper Transportation Billing](#)

SL noted that the Workgroup was anticipated to reconvene on 1<sup>st</sup> September 2015; however, an action remained outstanding for the Proposer to develop a set of business rules to assist with the development for the solution.

**13. AUTHORITY UPDATES**

SL noted that, following a communication from iGTs (via the Code Administrator) to Ofgem, the Authority had notified that implementation of iGT072 should be deferred pending the development of a further Modification. Implementation of iGT072 had been agreed as 1<sup>st</sup> October 2015; however, subsequent to the confirmation that Single Service Provision changes would not be implemented until 1<sup>st</sup> October 2016, Xoserve had advised that further work would be required to understand the impact of the non-effective window for the new date.

Ofgem agreed that the date for implementation of iGT072 would be indefinitely deferred pending the development of the solution for the new Modification. JR thanked the Code Administrator for progressing the matter so promptly with Ofgem, particularly given the urgency of the matter. KD noted that she would have preferred to have sight of the correspondence before it had been sent, but appreciated the urgency of the issue restricted the possibility in this instance.

SL considered that a further letter might be required to defer the implementation of iGT039 in the same manner. At the request of the Panel, the Code Administrator agreed to draft a letter to Ofgem accordingly and circulate to the Panel for information.

**Action 15-08-01: Code Administrator to send a letter to Ofgem requesting that the implementation of iGT039 be deferred to align with the date agreed in the UNC.**

SL advised that a revised Notice of Implementation would be required for each of the Self-Governance Modifications already agreed by the Panel: iGT070S, iGT073S, iGT076S, iGT077S, GPL048S. The Panel agreed with this approach, and the Code Administrator agreed to circulate revised implementation notices accordingly.

**Action 15-08-02: Code Administrator to circulate revised Notices of Implementation for iGT070S, iGT073S, iGT076S, iGT077S and GPL048S.**

Finally, SL considered that it might be necessary to raise a Fast Track Modification to amend the definition that was introduced into Code by iGT055, stating that the Project Nexus Go Live Date was 1<sup>st</sup> October 2015 (for the purposes of the Single Meter Supply Point regime). KS agreed to raise a Modification Proposal in preparation for the next Panel.

**Action 15-08-03: KS to raise a Modification Proposal amending the definition of “Project Nexus Go Live Date” within the iGT UNC.**
