## 7. UPDATE ON DEVELOPMENT GROUPS

### [iGT039 - Use of a Single Gas Transporter Agency](#)

JR provided an update on the Development Group activity for iGT039, on behalf of Workgroup Chair Gethyn Howard (Brookfield Utilities).

JR noted that a complete draft of the legal text had been sent to the external legal firm on 6<sup>th</sup> August 2014, and a teleconference had been confirmed with the legal firm on 14<sup>th</sup> August 2014 to confirm the agreed approach to the review. An initial review of the drafting had been received from the legal firm on 15<sup>th</sup> September 2014 and circulated to iGTs for a two week period for the submission of further comments. It was anticipated that the revised legal text would be circulated to the wider industry towards mid-October.

SL suggested that a workgroup meeting may be scheduled for early November, once parties had ample opportunity to consider the revised version of the legal text. JR confirmed that the current target was to bring the revised Modification to the December Modification Panel meeting, and subsequently circulate for consultation.

### [iGT056 – UPRN Provision](#)

JR noted that no progress had been made since the previous Modification Panel meeting. PR agreed to amend the website page for iGT056 to advise that feedback was being awaited from DECC with regard to whether a particular format or service provider for the UPRN had been mandated.

## [iGT066 - Aligning UNC with Licence conditions relating to European legislative change](#)

KN provided an update on the Development Group activity for iGT066, noting that he had been working with the Code Administrator to develop the legal text following comments received from Ofgem. Two versions of the legal text had now been drafted for consideration, and a preference would be sought at the iGT Shipper Work Group on 22<sup>nd</sup> September 2014.

### **10. FAST TRACK MODIFICATION PROPOSALS RECEIVED**

#### [iGT067F - Update of references to the CSEP NExA Table within the iGT UNC](#)

PR noted that iGT067F had been raised by ESP on 5<sup>th</sup> August 2014 as a Fast Track Self-Governance Modification Proposal. No objections to the Proposal were received by the Code Administrator during the time period set by the Modification Rules with respect to Fast Track Self-Governance Modifications.

The Proposal sought to amend the references in the legal text - due to be implemented on the 1st October 2014 - for approved modifications iGT053 and iGT060, because of changes introduced by approved modification iGT057S to the location of the CSEP NExA table.

The Panel unanimously **AGREED** that the Modification Proposal should be implemented and unanimously **AGREED** an Implementation Date of 1<sup>st</sup> October 2014.
