1. Welcome and apologies for absence

The Chair welcomed attendees to the meeting of the IGT UNC Modification Workstream. Apologies were received from Megan Coventry (SSE).

2. Confirmation of Agenda

The Chair confirmed the items for discussion as outlined in the final agenda. CB indicated that he would like to discuss developing an IGT industry contact list as AOB.

3. Approval of the Previous Minutes

Attendees reviewed the minutes from the Modification Workstream meeting held on 4th June 2019 (19-06). BH indicated that comments had been received from both BUUK and E.ON in regards to items 6 and 7. BH stated that the amendments would be reflected in the final minutes. The Chair indicated that subject to these amendments the minutes from the previous Workstream Meeting (4th June 2019) were approved as a true and accurate record of the meeting.

5. Cross-Code Modification Implications

The Chair introduced a document prepared by the Code Administrator which is used to track UNC modifications which could have an impact on the IGT UNC.

The Workgroup reviewed the document and discussed the possible implications to the IGT UNC. The discussion is detailed below;

6. Review Groups

RG005 - IGT UNC Review of Consequential Changes resulting from Faster Switching arrangements

The Chair informed workgroup members that the version 10.9REC and supplementary documentation had been sent to Ofgem. BH indicated that this had been included in the Ofgem's Switching Programme and Retail Code Consolidation (REC) consultation. The workgroup members raised concerns around the best method to manage the IGT UNC until the implementation of the REC. Workgroup members indicated that they would like the Code Administrator to draft a response in relation to the REC consultation. The workgroup members indicated that response should indicate a brief description of the IGT UNC Governance arrangements and the independent approach that is being taken by to manage the code during the transition period. The workgroup members asked the Code Administrator to have an initial high level draft response for an initial review at the July Panel. This response could be developed at the August workstream for a final decision at the August Panel.

7. Review Groups

RG006 - Review of metering arrangements in the IGT UNC

The Chair indicated that comments on the review of metering arrangements questionnaire in the IGT UNC feedback had been received from four IGTs. The Chair summarised the document to workgroup members. KD indicated that based on the Panel outcomes and discussions at the previous workstream an impasse had been reached. Her view was that going forward a modification(s) would be raised rather than continuing review group discussions. JR asked KD if she would be sending any future modification drafting in regards to other areas of the review group scope. KD indicated that parties would not be receiving any modification drafting and it would proceed through the formal modification process. VP indicated that she was happy that the scope of the review group had been completed. The Chair asked KD if the review group report could be produced offline and then taken to the July Panel. JR indicated that she would prefer if it was to be completed offline, then it should be brought back to workstream in August for it to be reviewed. The Chair indicated that the Code Administrator and KD would draft the review group report.

IGT128 - Amendment of definitions in D1.2

The Chair indicated that this modification was being treated as a draft modification. KD indicated that this modification was derived from the work carried out during June's workstream meeting as part of the RG006 Review Group. KD indicated that this modification was based exactly on the outcomes from the June workstream meeting. CH indicated concerns around section three of the modification proposal in regards to question two 'The responses for Q2 – "Meter Installation Works" '. CH indicated that the reference "completed as multiple jobs" does not apply to new connections. It was further queried as to why this statement was in the "Why change" section as there did not appear to be any reference to it in the Solution section. KD indicated that she would take this back to her internal metering team. CH indicated that the GT installs the service but not necessarily the meter if there is a third party MAM. KD stated she would check with her internal sponsor to ascertain if they are happy for this sentence to be removed. The Chair reiterated that the modification should be worded in line with the proposed legal text which currently has not introduced any requirements for installation works to be completed solely in a single visit.



CH raised her concerns to the legal text in regards to the additional sentence in Section D1.2.c in relation to 'Where required, the Meter Installation Works will include any pipe fittings and up to 1m of pipework required to connect the outlet of the Supply Meter to the Consumer's installation'. JR indicated that 'will' should be changed to 'may'. VP highlighted her concerns in regards to the removal of housings from section D1.2. due to the potential material impact on consumers. VP also highlighted that there might be a misalignment with MAMCoP and therefore the proposed route of self-governance of this modification may not be appropriate thus authority direction might be required. VP, JR and CB agreed to review MAMCoP and other documentation in relation to 'housings' and feedback to KD by Friday 5th July 2019. KD indicated that the key aim of the review group was to remove ambiguity and was therefore not willing to vary the modification in this area.

Action MWS19/07-03: KD to review internally the area of the Modification referencing "Multiple jobs".

Action MWS19/07-04: VP, JR and CB to review MAMCoP and other documentation in relation to 'housings' and feedback to KD by Friday 5th July 2019.

8. Review Groups

RG007- Secure measures of sending electronic communication and password protection

KD indicated that she wanted to hear suggestions from the workgroup, but with the intention of not being too prescriptive. JR indicated that each organisation has its responsibilities in terms of GDPR compliance. KD stated that any ad hoc information with personal data in it should be password protected and this single standard should be adopted. KD highlighted that when the CDSP sends any information in regards to MPRN level data then it is always encrypted. JR stated that she wanted to determine what the review group was trying to fix. KD informed the workgroup that this review group aims to put in place mechanisms and processes that will become codified protocols. KM highlighted that by adding this password protection it adds another level of policing. KM reiterated that the current process of sending personal data via email without encryption is not secure.

AJ asked the proposer what outcomes they wanted to achieve from this review group and what was the risk them not being mitigated. RK indicated that this review group intended to understand the scope of what Eon would feed into the modification. RK indicated that the scope of the IGT118 modification did not cover all MPRN level data and therefore this was the reasoning for setting up this review group. KD indicated that the current information security standards do not meet the standards of her organisation. The Chair indicated that the code already highlights password protection in section K23.2 which was the subject of IGT118.

VP commented that ultimately the penalty if a breach occurs in regards to personal data it will be a GDPR issue. AJ indicated that if there was an individual GDPR breach this would result in the whole process being put under scrutiny by the Information Commissioner's Office (ICO). KM indicated that the preferred mechanism to transfer data has not been determined by the Secure Communications Working Group (SCWG). VP indicated that parties should go back to their organisations and review



their GDPR compliance. KD indicated that the definition of 'Protected Information' needed to be reviewed by parties and this should be fed back at August's workgroup. The Chair asked if a technical subgroup was required at this time of which the proposer declined. KM reiterated the significance of protecting personal data. AJ stated that an organisation is responsible for its own data protection and security in legislation, however in doing that it would want to be assured that any organisation to which it sent data were similarly competent in data protection and security. RK indicated that she will take away all these suggestions to help form the modification and allow a more focussed discussion to take place.

9. Modification Workgroups

IGT119 - Opening Class 1 read services on IGT Meter Supply Points to Competition

The Chair indicated that this modification has been withdrawn.

10. Modification Workgroups

Draft IGT Average NEXA AQ Values Table 2019

The Chair indicated the Draft IGT Average NExA AQ Values Table 2019 was released on the IGT UNC website on 10th June 2019. Workgroup members raised no concerns over the proposed NExA AQ Values Table. JR indicated that the average AQ has gone down over the last seven years. The Chair indicated that the Draft IGT Average NExA AQ Values Table 2019 will be taken to July's Panel for ratification.

Action MWS19/07-07: Code Administrator to add Draft IGT Average NExA AQ Values Table 2019 to July Panel Agenda.

11. IGT UNC Known Issues Register

The Workgroup reviewed the current items recorded on the known issues register. The Workgroup agreed with the following changes and comments;

- SPAA MDD references to be removed from the Known Issues Register as this is now captured in the REC log.
- BU-UK to chase CDSP for an update on Shipper User Verifications of Supply Meter Point Isolations.



Action MWS19/07-08: Code Administrator to remove SPAA MDD references to the Known Issues Register.

Action MWS19/07-09: BU-UK to chase CDSP for an update on Shipper User Verifications of Supply Meter Point Isolations.

12. AOB

Communication between Pipeline Operators and Pipeline Users

JR highlighted the issue that there is no IGT UNC Shipper contact list. JR stated that this has caused problems for organisations in the past. JR provided examples where she has been unable to contact Shippers for example when she had been alerted that an organisation had been hacked.

JR asked workgroup members if they believed that this list would be useful for them and whether or not the IGT UNC has contract managers like other codes. KD indicated that the best way to achieve this would be through a codified method. AJ indicated that this list would need to be maintained once the process has started. It was confirmed by workgroup members that IGTs would provide the Code Administrator with a list of Shippers on their networks. BH indicated before anything was processed from the Code Administrator perspective, he would check with their internal compliance team. KD indicated that an email could be sent over the JO for distribution to all Shippers to provide a point of contact for the IGTs.

Action MWS19/07-10: Code Administrator to speak to internal compliance team in regards to creating an IGT shipper contact list

Action MWS19/07-11: IGTs to provide the Code Administrator with a list of Shippers on their networks.

Action MWS19/07-12: Code Administrator to send out communications to the JO in regards to obtaining shipper contact details for IGTs.
