1 Summary

What

The individual Network Code of Energetic Gas Limited needs to be amended to reflect their new company name.

Why

Energetic Gas Limited changed their company name to Last Mile Gas Limited on 24th September 2019.

How

Updating all references to Energetics Gas Limited within the Individual Network Code to its new name of Last Mile Gas Limited.

2 Governance

Justification for Fast Track Self-Governance Procedures

The modification seeks to update the company's legal registered company name within the company's individual network code. This qualifies as a housekeeping modification only.

The Proposer of this modification determines that this should be progressed as a Fast Track change and that modification also meets the criteria for Self- governance.

10 Consultation

Panel invited representations from interested parties with the Consultation closing on 13th November 2019. No responses were received following a full 15-day consultation period.

11 Panel Discussions

Discussion

BH informed Panel members that no consultation responses were received by the Code Administrator for this modification ENE002F.

Consideration of the Relevant Objectives

All Panel members agreed that this modification meets the criteria set out in Objective F and the published criteria for fast track Self-Governance modification.

Determinations

The vote was carried out with three Pipeline Operators and two Pipeline Users.

The Panel agreed by unanimous vote that this modification was still suitable for Fast Track Self Governance and should be implemented.

All Panel members agreed that the implementation of modification should be the same date that Last Mile Gas Limited is reflected within the Supply Point Administration Agreement (SPAA) Market Domain Data (MDD).

12 Recommendations

Panel Determination Self-Governance

Members agreed:

- that Modification ENE002F should be implemented.
