

Summary of IGT UNC Workgroups - 8th April 2021

Purpose:

This paper provides Panel members with a summary of IGT UNC Workgroup discussions where applicable each month.

Please note that the Modifications which will be subject to a decision at this meeting are not reflected in this document due to them already being discussed in the Panel meeting.

<u>IGT145 – Transfer of Sites with Low Valid Meter Reading Submission Performance from Classes 2 and 3 into Class 4</u>

The Workgroup heard that UNC0664V (Transfer of Sites with Low Valid Meter Reading Submission Performance from Classes 2 and 3 into Class 4) had been raised as a subsequent variant to UNC0664, the UNC equivalent to IGT145. The Modification had been changed from Authority decision to Self-Governance and the lockout period had been removed from the solution. As the Proposer of IGT145 was not present at the meeting, it was agreed that a discussion would be held offline to determine if the changes to UNC0664 would have an impact on IGT145.

<u>IGT154 – Introducing the concept of a derogation into the IGT UNC for Net Zero innovation project</u>

The Workgroup heard that IGT154 was the equivalent Modification to UNC0760 (Introducing the concept of derogation for Net Zero innovation into Uniform Network Code (UNC)).

The proposer introduced the modification to the Workgroup. The Workgroup had a number of questions around the solution which the Proposer clarified.

It was noted that there were some areas that the UNC Workgroup were challenging the Proposer of UNC0670 on, as there was concern around some overlapping areas.

The proposer had provided the ancillary document for the modification prior to the meeting and explained it was a guidance document that would set out the information needed for the derogation and whether to approve or reject it. The proposer added that timescales in the ancillary document would be mandatory and if parties required more time, then they would have to apply for an extension. The Proposer indicated that the timescale should be bespoke for each party and if a party were to run out of time, they would be asked to submit a new request. The derogation guidance document provided what detail would support why a derogation would be needed, how to apply and what the Panel may consider in the process.





The workgroup highlighted a risk that commercial boundaries with innovation and ideas might be crossed, dependent on what evidence was required. The Proposer agreed to develop some of the aspects raised offline.
