We agree with the proposer that Objectives A, B & C are positively impacted by this modification, by enabling capacity to be effectively managed across both the IGT network and the whole system.

Objective D may be positively impacted by ensuring Shippers taking on IGT supply points that are subject to an LDZCAA are not adversely affected by differing operational arrangements. However the very limited number of IGT sites subject to LDZCAA makes this negligible and unlikely to impact competition.

Objective F is positively impacted by bringing consistency across the 2 Codes, making it easier for parties to understand the arrangements and their obligations.
