# IGT 170 – Resolution of Missing Messages following Central Switching Service implementation and integration with REC Change R0067

Addition of new Clause 21 to Part CI – SUPPLY POINTS of the IGT UNC

# 21 Missing Definitive Registration Notification

For the purposes of this Clause 21 the provisions of paragraph 5.9 of Section G of the UNC shall apply.

Addition of new Clause 23 to Part E – METER READING of the IGT UNC

## 23 Missing DRN Reads

For the purposes of this Clause 23 the provisions of paragraph 5.18 of Section M of the UNC shall apply with the following changes:

Paragraph 5.18.5 shall be replaced with:

Following identification of a Missing DRN the CDSP shall, as soon as reasonably practicable following the Adjustment Review Date, determine (by reference to the Missing DRN Meter Reading, or any Replacement DRN Meter Reading) the Metered Quantity for the Adjustment Period for the relevant Supply Meter, and notify such to the relevant Pipeline Operator, the incoming User and the outgoing User, and where the Metered Quantity:

- (a) is greater than the Relevant Quantity, the IGT Transportation Charges and the Metering Charges where relevant payable in respect of the Adjustment Period shall be the responsibility of the incoming User, and the Pipeline Operator shall (in accordance with Part G Pipeline Transportation Charges, Invoicing, Payment and Code Credit, and Part D Supply Meter Installation and by credit or debit) make such adjustments as are required to the IGT Transportation Charges and the Metering Charges where relevant payable by the incoming User and the outgoing User in relation to the Adjustment Period;
- (b) is equal to or less than the Relevant Quantity, no adjustment shall be made to the IGT Transportation Charges and the Metering Charges where relevant payable in respect of the Adjustment Period (which shall remain the responsibility of the outgoing User).

Paragraph 5.18.6 shall be replaced with:

No other adjustment shall be made to the IGT Transportation Charges and the Metering Charges where relevant payable by the incoming User or outgoing User due to a Missing DRN in relation to relevant Supply Meter and the Adjustment Period following submission on any other Meter Reading with a Read Date which falls in the Adjustment Period.

# **Definitions**

Amend definitions in Part M - DEFINITIONS

"Adjustment Period" shall have the meaning ascribed thereto in the UNC;

"Adjustment Review Date" shall have the meaning ascribed thereto in the UNC;

"IGT Transportation Charges" shall have the meaning in Part G3.3(f)

"IGT Transportation Charges Invoice" shall have the meaning in Part G3.3(f)

**"Metering Charges" means** the Pipeline Operator's charges (if any) for the provision of Supply Meters and other services related to Supply Meters;

"Metering Charges Statement" means the document if any issued from time to time by the Pipeline Operator which is not the Transportation Statement and which sets out "Metering Charges";

"Missing DRN" shall have the meaning ascribed thereto in the UNC;

"Missing DRN Meter Reading" shall have the meaning ascribed thereto in the UNC;

"Relevant Quantity" shall have the meaning ascribed thereto in the UNC;

"Replacement DRN Meter Reading" shall have the meaning ascribed thereto in the UNC;

Amend the definition in Part G - PIPELINE TRANSPORTATION CHARGES, INVOICING, PAYMENT AND CODE CREDIT of the IGT UNC, Paragraph 3.3(f)

- (f) an "**IGT Transportation Charges Invoice**" is an invoice submitted by the Pipeline Operator to a Pipeline User pursuant to this Part G for "**IGT Transportation Charges**".

#### **Commentary**

# This modification legal drafting assumes that UNC 0836S has been implemented in the UNC.

#### 1. New Clause 21 to Part CI – SUPPLY POINTS

This Clause adds the UNC governance from UNC 0836S for this matter in its entirety, so that IGT Sites will be treated in the same manner as DN Sites by the CDSP in respect of Missing Definitive Registration Notifications.

2. New Clause 23 to Part E - METER READING

This Clause adds the UNC governance from UNC 0836S for this matter into the IGT UNC.

The replaced paragraph 5.18.5 requires the CDSP to calculate and inform all impacted Parties of the Meter Quantity. The paragraph also references IGT charges rather than DN transportation charges and requires the IGT to adjust transportation charges and metering charges (where relevant as some metering charges remain governed in the IGT UNC), in accordance with existing IGT UNC charging and invoicing governance and requires the IGT to make the adjustments only where the metered quantity is above the Relevant Quantity threshold set in the UNC governance.

The replaced paragraph 5.18.6 indicates that adjustments for this issue may only be made once regardless of other meter readings being received.

3. Revised Definitions

The revised definitions allow the use of the definitions 'Meter Charges' and 'IGT Transportation Charges' which are currently incorporated within other existing definitions in the IGT UNC.

Other definitions have been added to indicate that they are defined under the UNC.
