# 1 Summary

## What

This Modification is seeking to correct identified legal text errors following the implementation of IGT169<sup>1</sup>.

These errors were highlighted through UNC Modification 0899<sup>2</sup>, which corrected errors from UNC0701<sup>3</sup> and UNC0853<sup>4</sup>, and were then mirrored in IGT169. As a result, an associated IGT UNC Modification is required to ensure the two Codes are aligned.

For context, IGT169 was implemented on 29<sup>th</sup> April 2024. This Modification introduced alignment of Capacity requirements for the Network Exit Agreement (NExA) Supply Points in the UNC with Capacity requirements for Local Distribution Zone (LDZ) Connected System Exit Point (CSEP) Ancillary Agreement (LCAA) Supply Points in the IGT UNC.

Additionally, this Modification will also look to correct a number of identified housekeeping changes included in the Known Issues Register (as of January 2025).

## Why

Due to the varying timetables for the UNC Modifications and the cross-impacting nature of the associated legal texts changes, the changes to the UNC have become misaligned. This has had a knock-on impact to the IGT169 legal text which is now also misaligned.

Generally, housekeeping changes are required to ensure alignment of the IGT UNC with the UNC, so that the IGT UNC is pointing to the intended parts of UNC. Without this, the Codes become misaligned, introducing risks to industry parties where Code doesn't contain the correct obligations and processes.

## How

The legal text changes made in UNC0899 have been reviewed and a number of changes have been identified which also need to be made to IGT UNC, these are simple changes with a low impact to parties.

This Modification also seeks to include housekeeping changes required to legal text identified in the Known Issues register.

## 2 Governance

### Justification for Self-Governance

As a housekeeping Modification, this meets the Self-Governance criteria. There are no identified material impacts.

#### Self-Governance - The Modification:

- (i) is unlikely to have a material effect on:
  - (aa) existing or future gas consumers; and
  - (bb) competition in the shipping, transportation or supply of gas conveyed through pipes or any commercial activities connected with the shipping, transportation or supply of gas conveyed through pipes; and
  - (cc) the operation of one or more pipe-line system(s); and
  - (dd) matters relating to sustainable development, safety or security of supply, or the management of market or network emergencies; and
  - (ee) the uniform network code governance procedures or the network code modification procedures; and
- (ii) is unlikely to discriminate between different classes of parties to the uniform network code/relevant gas transporters, gas shippers or DN operators.

### Requested Next Steps

This Modification should:

- Subject to Self-Governance; and
- proceed to Consultation.

### Workgroup Discussions and Conclusions (April 2025)

The Workgroup considered the Proposer's rationale as set out above.

A question was raised regarding proposed changes to Part CII, Paragraph 5.6(a) and whether they would result in impacts on Central Data Services Provider (CDSP) systems, which may in turn impact the progression under Self-Governance. The Proposer advised that they had already spoken to the CDSP and they have confirmed that there is no impact to CDSP processes or systems. The Workgroup had no further comments or concerns on this matter.

The Workgroup unanimously agreed that this Modification should be progressed as a Self-Governance Modification Proposal, in line with the reasons given by the Proposer.

## 3 Why Change?

When IGT169 was implemented, it used legal text from its equivalent UNC Modifications (0701 and 0853). It has now been identified that the legal texts from these Modifications have become misaligned.

The IGT UNC Workstream includes a standing agenda item, the Known Issues Register that includes a list of known housekeeping changes that require an IGT UNC Modification to rectify. These changes need to be made to ensure the legal text correctly reflects the purpose and intention it was written for.

Additionally, alignment of the IGT UNC and UNC is prudent to allow for a more streamlined transition to the future Gas Network Code (GNC) as part of Energy Code Reform.

## Workgroup Discussions and Conclusions (April 2025)

The Proposer took the Workgroup through the solution and proposed changes to the IGT UNC.

The Proposer told Workgroup that they had explored potential impacts as a result of the proposed changes to Part CII, Clause 5.6(a), and whether there would be unintended impacts on CDSP systems and how “day” is defined. The Proposer went on to advise that the CDSP has confirmed that there is no impact on the CDSP processes or systems and that the change has no impact on how “day” is defined. The Workgroup had no further comments or concerns on this matter.

A Workgroup member questioned whether the proposed changes to Part CII, Clause 4.1 need to be considered in the context of the Modification IGT176, as that Modification will introduce provisions related to the NTS and if amended under this Modification may no longer apply within the Code. The Proposer and the member discussed this further and mutually agreed that there would not be an overlap between IGT175 and IGT176, and therefore the proposed changes under IGT175 would not need to be altered. This was accompanied by a brief, out-of-scope discussion of terminology pertinent to IGT176.

A typographical error in the supportive text above the table in the Solution section of this Report was identified, where the associated UNC Modification is incorrectly referred to as UNC0889 rather than UNC0899. Workgroup members agreed that this typographical error should be resolved in v2.0 of the Modification, which they were due to consider at this meeting.

An omission in the “IGT169 or Known Issues Register” column of the table found in the solution section of the Modification Report was also identified. It was pointed out that both the proposed changes for both Part E, Clause 22.1 and for Part K, Clauses 23.6, 23.7 and 23.9 did not contain any text in the aforementioned column. Workgroup members agreed to resolve this via the inclusion of the text “Known Issues Register” and “Identified whilst resolving IGT-UNC Part K, Clause 23.10 in the Known Issues Register” in this column, respectively.

The Workgroup Chair asked if the proposed changes to Part K, Clauses 23.6, 23.7 and 23.9 were new changes, as they had not been initially marked as having been identified in the Known Issues Register. The Code Administrator confirmed that these were identified during the investigation of changes proposed to Part K, Clause 23.10 (which was in the Known Issues Register). The Workgroup considered this and the new wording for the aforementioned column was agreed as a result.

The Code Administrator highlighted that the Modification Proposal was updated from V1.0 to V2.0 to correct a typographical error where proposed drafting changes for the “IGT’s New Connections Domestic Sites Only”, Clauses 2.2 and 2.5 were presented as PS1 and PS2, rather than PSA and PSB (respectively), as intended by the Proposer. Workgroup members agreed to proceed with V2.0 of the Modification Proposal containing these updates.

Following the discussion, the Workgroup agreed unanimously with the changes proposed under IGT175 and that there were unintended consequences as a result of these changes.

## 6 Impacts & Other Considerations

**Does this Modification impact a Significant Code Review (SCR) or other significant industry change projects, if so, how?**

### Workgroup Discussions and Conclusions (April 2025)

The Workgroup considered whether this Modification would have an impact of any SCR or significant industry change projects and agreed unanimously with the Proposal that there were no impacts.

### Workgroup Discussions and Conclusions (April 2025)

## Workgroup Discussions and Conclusions (April 2025)

The Workgroup considered potential Cross-Code impacts.

The Proposer advised the Workgroup that as the proposed changes to Code would only result in an alignment between the IGT-UNC and the UNC (where they were as a result of [UNC0899](#) and [UNC0881](#)) and housekeeping updates to make changes identified in the Known Issues Register, that there would no impacts on any other industry Code. Workgroup members unanimously with this view.

## Environmental Impacts

No foreseen environmental impacts, this is a housekeeping legal text amendment.

## Workgroup Discussions and Conclusions (April 2025)

The Workgroup considered potential environmental impacts and the Proposer's rationale as set out above. The Workgroup agreed unanimously with the proposer that this Modification will not result in any environmental impacts, on the basis that it is a housekeeping legal text amendment.

## Proposer's View

This Modification furthers Standard Relevant Objective f) *Promotion of efficiency in the implementation and administration of the Code* as this proposal is promoting accuracy in the IGT UNC Code Legal Text.

## Workgroup Discussions and Conclusions (April 2025)

The Workgroup considered the potential impact that IGT175 may have on the IGT UNC Relevant Objectives. They considered the Proposer's rationale as set out above and unanimously agreed with the proposer that this Modification will have a positive impact on Objective F) for the reasons set out by the Proposer.

# 8 Implementation

## Implementation Approach

The Proposer originally requested that this Modification be implemented as soon as possible. Noting that there are no foreseen costs or system changes associated with this Modification Proposal. The Workgroup have unanimously agreed that IGT175 should be implemented as part of the June 2025 Scheduled Release, subject to no appeals being received within the 15 Working Day appeal window.

## Workgroup Discussions and Conclusions (April 2025)

The Proposer originally requested that this Modification be implemented as soon as possible. Noting that there are no foreseen costs or system changes associated with this Modification Proposal.

The Code Administrator provided Workgroup members with two options for the implementation of IGT175. These options were as follows:

1. Implementation as part of the June 2035 Release, subject to no appeals being received within the 15 Working Day Appeal Window; or
2. Implementation as part of an ad-hoc release, which would also be subject to no appeals being received during the 15 Working Day Appeal Window.

The Workgroup considered these options and it was noted that implementation needed to happen soon to limit the length of time the UNC and IGT UNC were out of sync, given that UNC0899 was implemented on 28 March 2025. The Code Administrator confirmed that the current progression timescales would mean that the June 2025 Release was achievable. Workgroup members agreed that implementation as part of the Scheduled Release would be best and added that industry participants would need to be notified as part of the IGT-UNC Pre-Release processes that implementation of the Modification would be subject to an appeal window.

The Workgroup unanimously agreed that IGT175 should be implemented as part of the June 2025 Release.
