PROPOSED AMENDMENTS TO IGT UNC PART F – DAILY AND ANNUAL QUANTITIES AND SHRINKAGE

PART F - DAILY AND ANNUAL QUANTITIES ~~AND SHRINKAGE~~

1 General

- 1.1 For the purposes of this Part F the CSEP shall be treated as comprising separately;
- (a) a Connected System Exit Point in respect of all the NDM Supply Points (“**NDM CSEP**”);
 - (b) a Connected System Exit Point in respect of all the DM Supply Points (“**DM CSEP**”).

12 Pipeline shrinkage

~~12.1 For the purposes of this Code:~~

- ~~(a) “**Pipeline Shrinkage**”: means gas offtaken from the Large Transporter System at the CSEP which is lost from or unaccounted for as offtaken from the Pipeline, including gas lost or unaccounted for by reason of leakage, theft, meter error and meter correction.~~
- ~~(b) “**Pipeline Shrinkage Factor**”: is a factor calculated (as an average for all Days in the Gas Year), for any quantity to be offtaken from the Large Transporter System at the CSEP, as the sum of such quantity and the Pipeline Shrinkage attributable thereto divided by such quantity.~~

13 Calculation of Pipeline Shrinkage Factor

~~13.1 Not later than 1st August in each Gas Year the Pipeline Operator shall:~~

- ~~(a) in good faith and as accurately as is reasonably practicable:~~
 - ~~(i) assess whether the Pipeline Shrinkage Factor will in the current Gas Year have accurately reflected Pipeline Shrinkage; and~~
 - ~~(ii) estimate (in accordance with Clause 13.2) the value of the Pipeline Shrinkage Factor to apply in the following and in each Gas Year;~~
- ~~(b) provide to the Large Transporter such estimated value and assessment and details (sufficient to enable the Large Transporter to verify the same) of the basis on which such value was estimated and assessment was made.~~

~~13.2 The value of the Pipeline Shrinkage Factor to apply in a particular Gas Year shall be established so as to take account of the extent by which (in accordance with Clause 13.1(a)(i) it is assessed that Pipeline Shrinkage in the preceding year will be over or under-estimated.~~

~~13.3 Each Pipeline User acknowledges that the Pipeline Shrinkage Factor in respect of the First Gas Year is as set out in the IGTAD.~~

~~13.4 Each Pipeline User shall provide to the Pipeline Operator in a timely manner all relevant information in order to help the Pipeline Operator to comply with its obligations under clause 13.1(a).~~

~~13.5 The Pipeline Operator shall negotiate in good faith with the Large Transporter in respect of the determination of the Pipeline Shrinkage Factor, and shall use (as far as is reasonably practicable) the information provided to the Pipeline Operator by Pipeline Users in accordance with Clause 13.4.~~

INTRODUCTION OF NEW IGT UNC PART FI – SHRINKAGE AND INDEPENDENT SHRINKAGE EXPERT

PART FI - SHRINKAGE AND INDEPENDENT SHRINKAGE EXPERT

1 General

1.1 Introduction

1.1.1 This Part FI sets out:

- (a) provisions relating to the Shrinkage and the calculation of Pipeline Shrinkage Factor; and
- (b) provisions relating to the Independent Shrinkage Expert.

2 Pipeline shrinkage

2.1 For the purposes of this Code:

- (a) **"Pipeline Shrinkage"**: means gas offtaken from the Large Transporter System at the CSEP which is lost from or unaccounted for as offtaken from the Pipeline, including gas lost or unaccounted for by reason of leakage, theft, meter error and meter correction.
- (b) **"Pipeline Shrinkage Factor"**: is a factor calculated (as an average for all Days in the Gas Year), for any quantity to be offtaken from the Large Transporter System at the CSEP, as the sum of such quantity and the Pipeline Shrinkage attributable thereto divided by such quantity.

3 Calculation of Pipeline Shrinkage Factor

3.1 Not later than 1st August in each Gas Year the Pipeline Operator shall:

- (a) in good faith and as accurately as is reasonably practicable:
 - (i) assess whether the Pipeline Shrinkage Factor will in the current Gas Year have accurately reflected Pipeline Shrinkage; and
 - (ii) estimate (in accordance with Clause 3.2) the value of the Pipeline Shrinkage Factor to apply in the following and in each Gas Year;
- (b) provide to the Large Transporter such estimated value and assessment and details (sufficient to enable the Large Transporter to verify the same) of the basis on which such value was estimated and assessment was made.

3.2 The value of the Pipeline Shrinkage Factor to apply in a particular Gas Year shall be established so as to take account of the extent by which (in accordance with Clause 3.1(a)(i) it is assessed that Pipeline Shrinkage in the preceding year will be over or under-estimated.

3.3 Each Pipeline User acknowledges that the Pipeline Shrinkage Factor in respect of the First Gas Year is as set out in the IGTAD.

- 3.4 Each Pipeline User shall provide to the Pipeline Operator in a timely manner all relevant information in order to help the Pipeline Operator to comply with its obligations under clause 3.1(a).
- 3.5 The Pipeline Operator shall negotiate in good faith with the Large Transporter in respect of the determination of the Pipeline Shrinkage Factor, and shall use (as far as is reasonably practicable) the information provided to the Pipeline Operator by Pipeline Users in accordance with Clause 3.4.

4 Independent Shrinkage Expert

- 4.1 For the purposes of Clauses 4 and 5 of this Part FI and in respect of matters relating to the Independent Shrinkage Expert:
- (a) **"Independent Shrinkage Statement"** is the document established, maintained and published by the Independent Shrinkage Expert in accordance with paragraph 5 of TPD Section N of the UNC;
 - (b) **"Independent Shrinkage Expert"** is the person appointed and whose role and terms of engagement are specified in accordance with paragraph 5 of TPD Section N of the UNC;
 - (c) **"Independent Shrinkage Model"** is as defined in paragraph 5.1.1(h) of TPD Section N of the UNC;
 - (d) **"Independent Shrinkage Document"** is as defined in paragraph 5.1.1(e) of TPD Section N of the UNC.

Each Pipeline Operator and each Pipeline User shall comply with the requirements in TPD Section N Paragraph 5 of the UNC in respect of matters relating to the Independent Shrinkage Expert. No requirements in the IGT UNC shall be deemed to prevent or interfere with each Pipeline Operator's and each Pipeline User's ability to comply with these provisions.

5 Provision of Information

- 5.1 Each Pipeline Operator and each Pipeline User shall cooperate with and (subject to any restriction on disclosure) shall not unreasonably withhold information reasonably requested by the Independent Shrinkage Expert in connection with the preparation of the Independent Shrinkage Statement or otherwise required for matters relating to the Independent Shrinkage Expert as set out in Clauses 4 and 5 of this Part FI (and each Pipeline Operator and each Pipeline User) acknowledge the Independent Shrinkage Expert may notify the Authority in the event any such requested information is not **provided**.
- 5.2 Each Pipeline Operator and each Pipeline User shall, to the extent provided for in the Independent Shrinkage Document, co-operate with and provide data to the Independent Shrinkage Expert in connection with the creation and on-going development of the Independent Shrinkage Model.

INCLUSION OF DEFINITIONS INTO IGT UNC PART M - DEFINITIONS

"Independent Shrinkage Statement" is the document established, maintained and published by the Independent Shrinkage Expert in accordance with paragraph 5 of TPD Section N of the UNC;

"Independent Shrinkage Expert" is the person appointed and whose role and terms of engagement are specified in accordance with paragraph 5 of TPD Section N of the UNC;

“Independent Shrinkage Model” is as defined in paragraph 5.1.1(h) of TPD Section N of the UNC;

“Independent Shrinkage Document” is as defined in paragraph 5.1.1(e) of TPD Section N of the UNC.

“Pipeline Shrinkage” shall have the meaning in Part F142.1(a);

“Pipeline Shrinkage Factor” shall have the meaning in Part F142.1(b);
